



Petition to tell the SA Mayor & Council to make 'pp South Texas' move its medical surgeries and cold storage from 2140 Babcock and protect the sanctity of family homes



**Petition to our Local Political Communities,** We the undersigned residents of Dreamhill Estates, neighbors, business owners and employees, and citizens of SA, express our desire for the City Council to amend the Unified Development Code (UDC) to direct the zoning district in which an ambulatory surgical center and an abortion facility are allowed to be located only in C-3 or C-2 zones, and further desire the denial of a Certificate of Occupancy, Zoning Variance, Zoning Change, or Re-Platting for Delantero Investors LTD/"Planned Parenthood South Texas", located at 2140 Babcock, San Antonio, Texas, 78229 due to serious problems which include but are not limited to:

- Frequent illegal parking on and around private residences and business properties, • Damage to existing infrastructure including streets, driveways and sidewalks, • Damage to business and residential drives, lots, lawns and landscaping, • Increase in police presence and traffic flow, • Increase in traffic flow on Babcock and through Dreamhill Estates neighborhood, • Increase in traffic danger due to increased U-turns at Babcock & Beverly Mae and illegal left turns from Delantero Development onto Babcock • Proximity to children by way of a childcare facility and a children's counseling center across the street, respectively, as well as children whose families live in the neighborhood, • Possible exposure to biomedical waste such as blood borne pathogens and fetal products via area wildlife such as raccoons, foxes, wild dogs, feral cats and possums, • Subsequent irreparable decrease in property value due to the nature of the "Planned Parenthood" business. "Planned Parenthood South Texas" must cease and desist all medical surgeries and use of cold storage at 2140 Babcock as it is within 50 feet of the sanctity of family homes.
