Ballot Propositions

(Propuestas para la Boleta)

• Proposition 1 -- Yes

Texas should replace the property tax system **with an alternative other than an income tax and require voter approval** to increase the overall tax burden.

(Propuesta 1) (Si)

(Texas debe reemplazar el sistema de impuestos sobre propiedades con una alternativa diferente a los impuestos sobre los ingresos, y requerir la aprobación de los votantes para incrementar la carga fiscal.)

• Proposition 2 -- Yes

Texas cities and counties should be required to comply with federal immigration laws or be penalized by loss of state funds.

(Propuesta 2) (Si)

(Las ciudades y condados de Texas deben ser requeridos a cumplir con las leyes federales de migración o ser penalizados con la pérdida de fondos estatales.)

• Proposition 3 -- Yes

Texas should prohibit governmental entities from collecting dues for labor unions through deductions from public employee paychecks.

(Propuesta 3) (Si)

(Texas debe prohibir que las entidades gubernamentales recauden cuotas beneficiosas para las uniones laborales por medio de deducciones a los cheques de pago de empleados públicos.)

• Proposition 4 -- Yes

Texas and its citizens should strongly assert 10th Amendment Rights guaranteed by the U.S. Constitution which states "The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people."

(Propuesta 4) (Si)

(Texas y sus ciudadanos deben afirmar los derechos garantizados por la decimal enmienda a la Constitución de los EUA "Los poderes que la Constitución no delega a los Estados Unidos ni prohíbe a los Estados, quedan reservados respectivamente a los Estados o al pueblo.")
